TERMS OF ENROLLMENT

By signing this Enrollment Form, I (we) agree to the following: (1) participant and any guests in his/her party will abide by the terms of this Agreement at all times during the period of enrollment and will comply with all rules and regulations posted or otherwise communicated, (2) in case of illness or injury, The Salvation Army is authorized to secure emergency medical treatment at the participant's expense, (3) The Salvation Army Community Center reserves the right to remove from the facility or terminate the enrollment of any participant who fails to comply with any posted rules and regulations or otherwise breaches the terms of this Agreement, in which case participant will not be entitled to a refund of fees, and (4) enrollment is not transferable, and (5) grant permission for The Salvation Army to make visual recordings of all individuals listed on this form for its responsible use.

CONSENT TO TAKE AND PUBLISH PHOTOGRAPHS, VIDEO, AUDIO, AND MEDIA RECORDINGS—I hereby grant The Salvation Army, its agents and those by whom it is commissioned, unrestricted and unlimited license, right, permission, and consent to use and reuse, copyright, print, reproduce, publish, and republish, for any and all trade purposes or commercial or other advertising or public purposes, said media usage depicting me or a minor for whom I have legal responsibility. I warrant that I have not limited or restricted the use of my name or photograph to the use of any organization or person.

EQUIPMENT RETURN AGREEMENT (IF APPLICABLE)—I (We) understand that any issued equipment is borrowed and MUST be returned after the last class/game. I (We) agree to return issued equipment after the last class/game, if equipment is not returned after the last class/game or is damaged beyond repair, I (We) understand that I (We) am (are) financially responsible for it's replacement.

CLASS AND PROGRAM CANCELLATIONS—Full payment is expected at the time of enrollment. No cash refunds are given unless the program is cancelled by The Salvation Army. The Community Center will determine if a class needs to be cancelled due to low enrollment 48 hours prior to the start of class. If the program is cancelled by The Salvation Army, you will be given the choice of a full credit or a cash refund. If you request to cancel your class enrollment five or more days prior to the first class, you will receive a full credit on a gift card minus a \$5 processing fee or you may choose to transfer to another session if available. Requests made less than five days prior to the start date are not eligible for a refund or credit, except in the case of personal emergencies. No credits or pro-rated credits will be issued for missed days of camp or class due to illness, partial attendance, behavior issues, or any other reason.
